The Government of Nepal has received a grant from the Asian Development Bank (ADB Grant No. 0093-NEP), grant from Department for International Development (DFID)-Grant 2008, grant from Swiss Agency for Development and Co-operation (SDC)-grant and loan from the OPEC fund for International Development (OFID)-Loan No. 1185P towards the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Construction of **Bankatta-Bagaee Road**.

2. The Office of District Development Committee (DDC), District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office (DPO), Chitwan now invites sealed Bids for Construction (Earthwork in Excavation, Construction of cross drainage, Drain, Premix Carpeting, etc) of **Bankatta-Bagaee Road**. Bidding is open to bidders from eligible source countries of the ADB.

3. To obtain further information and inspect the Bidding Documents for Procurement of Works. 4. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One Envelope procedure. Only eligible bidders with the following key qualifications should participate in this bidding:

- a) The Bidder must have experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last five (5) years prior to the applications submission deadline.
- b) The bidder must have following **construction experience** and **Average Annual Turnover**

The Bidding document, in English language, will be made available to interested bidder on the submission of a written application from office of the District Development Committee, District Technical Office, District Project Office, Bharatpur, Chitwan and upon payment of amount of a non-refundable fee of NRs 3000 (NRs three thousand only) on or before the office hour until **3rd October, 2010**. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative.

6. Bid must be valid for a period of 90 days after the bid submission deadline and must be accompanied by a bid security for the amount as specified in para 10 and valid for 30 days beyond bid validity period. Bid security should be in the form of Bank Voucher deposited in the account No : Kha-3/124 , Dharauti Khata at Rastriya Banijya Bank ,Bharatpur, Chitwan branch, or Bank guarantee drawn in favour of District Project office, Bharatpur, Chitwan.

7. The Bids received will be opened in the presence of Bidders' representatives who choose to attend at 13.00 hrs on **4th October, 2010** at the office mentioned in Para 5.

8. A pre bid meeting will be held on **20th September, 2010** at 12:00 hours at the office mentioned in Para 5. All interested bidders are encouraged to attend the pre-bid meeting.

The Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Chitwan reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
