The Government of Nepal has received a grant from the Asian Development Bank (ADB Grant No. 0093-NEP), grant from Department for International Development (DFID)-Grant 2008, grant from Swiss Agency for Development and Co-operation (SDC)-grant and loan from the OPEC fund for International Development (OFID)-Loan No. 1185P towards the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Reconstruction and Rehabilitation of Khaniyakharka-Kamarebhanjyang Rural Road.

2. The Office of District Development Committee (DDC), District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office (DPO), Sindhulimadhi, Sindhuli now invites sealed Bids for Reconstruction and Rehabilitation (cutting & filling of earthworks, construction of retaining structures, line drain, gravelling etc.) of Khaniyakharka-Kamarebhanjyang road. Bidding is open to bidders from eligible source countries of the ADB.

3. 4. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One Envelope procedure. Only eligible bidders with the following key qualifications should participate in this bidding:

- a) The Bidder must have experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last five (5) years prior to the applications submission deadline.

- b) The bidder must have following **construction experience** and **Average Annual Turnover**

The Bidding document, in English language, will be made available to interested bidder on the submission of a written application to the address mentioned in Para 2 and upon payment of amount of a nonrefundable fee of NRs 3000 (NRs three thousand only) on or before the office hour until 11 April 2010. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative. Bid shall be submitted to the address mentioned in Para 2.

6. Bid must be accompanied with bid security Amount mentioned in para 10 and it should be in the form of Bank Voucher deposited in the account No: Kha-3, Dharauti- 351 at Rastriya Banijya Bank, Sindhulimadhi branch, or Bank guarantee drawn in favor of this office, having a validity period of 90 (ninety) days from the last date of submission of the bid. Bid security must remain valid for 30 days after the bid validity period

7. The Bids received will be opened in the presence of Bidders' representatives who choose to attend at 13.00 hrs on 12 April 2010 at the office mentioned in Para 2.

8. A pre bid meeting will be held on 01 April 2010 at 12:00 hours at the office mentioned in Para 2. All interested bidders are encouraged to attend the pre-bid meeting.

The Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Sindhulimadhi Sindhuli reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
