The Government of Nepal has received a grant from the Asian Development Bank (ADB Grant No. 0093-NEP), grant from Department for International Development (DFID)-Grant 2008, grant from Swiss Agency for Development and Co-operation (SDC)-grant and loan from the OPEC fund for International Development (OFID)-Loan No. 1185P towards the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Reconstruction and Rehabilitation of Pathari-Dainiya-Sikati Rural Road.
2. The Office of District Development Committee (DDC), District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office (DPO), Biratnagar-Morang now invites sealed Bids for Reconstruction and Rehabilitation (cutting & filling of earthworks, pavement works, structure works etc) of Pathari-Dainiya-Sikati Road. Bidding is open to bidders from eligible source countries of the ADB.
3. To obtain further information and inspect the Bidding Documents for Procurement of Works. Interested bidders may contact at the address mentioned in Para 2.
4. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage; One Envelope procedure. Only eligible bidders with the following key qualifications should participate in this bidding:
 - a) The Bidder must have experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last five (5) years prior to the applications submission deadline.
 - b) The bidder must have following **construction experience** and **Average Annual Turnover**

- c) The Bidder must demonstrate his ability to provide at least one engineer with minimum five years of relevant experience and other personnel as detailed in section:3 of bidding documents.
- d) The Bidder must demonstrate that it has equipments as detailed in section: 3 of bidding documents.
5. The Bidding document, in English language, will be made available to interested bidder on the submission of a written application to the address mentioned in Paragraph-2 or District Administration Office, Biratnagar, Morang upon payment of amount of a nonrefundable fee of NRs 3000 (NRs three thousand only) on or before the office hour until September 16, 2010 The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative.
6. Bid must be valid for a period of 90 days after the bid submission deadline and must be accompanied by a bid security for the amount as specified in Para 10 and valid for 30 days beyond bid validity period. Bid security should be in the form of Bank Voucher deposited in the account **No: Sa-Aa133120, Dharauti at Nepal Rastra Bank, Biratnagar**, or Bank guarantee drawn in favor of this office.
7. The Bid shall be submitted before 12:00 Hrs on September 17, 2010 at District Administration Office, Biratnagar, Morang. The Bids received will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on September 17, 2010 at District Administration Office, Biratnagar, Morang. .
8. A pre bid meeting will be held on September 3, 2010 at 12:00 Hours at the office mentioned in Paragraph-2. All interested bidders are encouraged to attend the pre-bid meeting.
9. The Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Biratnagar, Morang reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
