The Government of Nepal has received a grant from the Asian Development Bank (ADB Grant No. 0093-NEP), grant from Swiss Agency for Development and Co-Operation (SDC- Grant), grant from Department for International Development (DFID)-Grant 2008 and loan from the OPEC fund for International Development (OFID)-Loan No. 1185P towards the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Reconstruction and Rehabilitation of Surunga-Saranmati-Tagandubba-Digal Bank Road under National Competitive Bidding Procedures.

2. The Office of District Development Committee (DDC), District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office (DPO), Jhapa now invites sealed Bids for Reconstruction and Rehabilitation (Earthwork in excavation and Embankment, Preparation of sub-grade, sub-base, base, Premix carpeting work, etc.) of Surunga-Saranmati-Tagandubba-Digal Bank Road. Bidding is open to bidders from eligible source countries of the ADB.

3. 4. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One Envelope procedure. Only eligible bidders with the following key qualifications should participate in this bidding:

- a) The Bidder must have experience under construction contracts in the role of contractor, sub-contractor, or management contractor for at least the last five (5) years prior to the applications submission deadline.
- b) The bidder must have following **construction experience** and **Average Annual Turnover**

5. The Bidding document, in English language, will be made available to interested bidder on the submission of a written application to **District Technical Office, Bhadrapur, Jhapa and District Administration Office , Bhadrapur, Jhapa** upon payment of amount of a nonrefundable fee of NRs 5000.00 (NRs. Five Thousand only) on or before the office hour until 18th July 2010. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative.

6. Bid must be valid for a period of 90 days after the bid submission deadline and must be accompanied by a bid security for the amount as specified in para 10 and valid for 30 days beyond bid validity period. Bid security should be in the form of Bank Voucher deposited in the account No: Kha-3, Dharauti- 390 at Rastriya Banijya Bank, Bhadrapur branch, or Bank guarantee drawn in favor of this office.

7. The Bids should be submitted at the District Administration Office, Bhadrapur, Jhapa. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 19th July, 2010 at the District Administration Office, Bhadrapur, Jhapa.

8. A pre bid meeting will be held on 5th July, 2010 at 13:00 hours at **District Technical Office, Jhapa**. All interested bidders are encouraged to attend the pre-bid meeting.

9. The Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Jhapa reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
