1. The Government of Nepal has received a grant from the Asian Development Bank (ADB Grant No. 0093-NEP), grant from Department for International Development (DFID)-Grant 2008 and loan from the OPEC fund for International Development (OFID)-Loan No. 1185P towards the cost of **Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP)**, and it intends to apply part of the proceeds of this grant to payments under the contract for Reconstruction and Rehabilitation of Khopasi Taldhunga Rural Road (Kamidada Taldhunga sector) under National Competitive Bidding Procedures.
2. The Office of District Development Committee (DDC), District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office (DPO), Dhulikhel-Kavrepalanchowk now invites sealed Bids for Reconstruction and Rehabilitation (cutting & filling of earthworks, construction of retaining structures etc) of Khopasi Taldhunga road as detailed in Particular Condition of Contract (PCC) 1.1-j. Bidding is open to bidders from eligible source countries of the ADB.
3. To obtain further information and inspect the Bidding Documents for Procurement of Works by National Competitive Bidding Procedures interested bidders may contact the Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Dhulikhel Kavrepalanchowk, Phone No: 011-490806.
4. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One Envelope procedure and is open to all Bidders from eligible source countries of the ADB. Only eligible bidders with the following key qualifications should participate in this bidding:
 - a) The Bidder must have experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last five (5) years prior to the applications submission deadline.
 - b) The bidder must have following **construction experience** and **Average Annual Turnover**

- c) The Bidder must demonstrate his ability to provide at least one engineer with minimum five years of relevant experience and other personnel as detailed in section:3 of bidding documents.
 - d) The Bidder must demonstrate that it has at least two compressors, one road roller, truck/tippers and other equipment as detailed in section: 3 of bidding documents.
5. The Bidding document, in English language, will be made available to interested bidder on the submission of a written application to the address mentioned in Para 2 and upon payment of amount of a nonrefundable fee of NRs 3000 (NRs three thousand only) on or before the office hour until 30 June 2009. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative.
 6. Duly completed Bid shall be enclosed in a sealed envelope bearing the bid No. and the name and address of the bidder and shall be addressed to the Office mentioned in Para 2. The bid form in sealed envelope shall be submitted to the Office mentioned in Para 2 above on or before 12.00 hrs of 1 July 2009. Documents received after this deadline will not be

accepted. If the last date of purchasing, submission and opening falls on government holiday then the next working day shall be considered the last date.

7. Bid must be accompanied with bid security Amount mentioned in para 11 and it should be in the form of Bank Voucher deposited in the account No: Kha-3, Dharauti- 89 at Rastriya Banijya Bank, Dhulikhel branch, or Bank guarantee drawn in favor of this office, having a validity period of 90 (ninety) days from the last date of submission of the bid. Bid security must remain valid for 30 days after the bid validity period

8. The Bids received will be opened in the presence of Bidders' representatives who choose to attend at 13.00 hrs on 1 July at the office mentioned in Para 2.

9. A pre bid meeting will be held on 16 June 2009 at 12:00 hours at the office mentioned in Para 2. All interested bidders are encouraged to attend the pre-bid meeting.

10. The Office of District Development Committee, District Technical Office, Rural Reconstruction and Rehabilitation Sector Development Program (RRRSDP), District Project Office, Dhulikhel Kavrepalanchowk reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
